

Table of Identification of Risks of Hazard for toy commodities

1. The risks of hazard for commodities may be identified by the risk factors that include characterization of commodity, testing results, market surveillance, information of commodity safety from domestic and foreign, and damage caused from unsafety commodity.
2. Low risk of hazard toy commodities:

Early development toys : Toys that could re-write on the books for the acknowledgement of children in size, color; coupling; classification, alphabets, numbers, characters, mathematics, logic and reasoning. 2. Learning toys: <ol style="list-style-type: none"> (1) Books with interaction function that contain folding elements (Turn page to get different information), moveable objects (Pull the objects to change the picture), and interactions modelling objects (modelling card, stickers). (2) Bath books, fabric books and touch books with few pages of books and the material are unbreakable. (3) Musical books with sound or light. 3. Puzzle toys: Scrapbooks mainly designed for cutting. 	<ol style="list-style-type: none"> 1. Characterization of commodity: Major composition of the commodity is paper or plastic. Sticker toys, Sticker books, Transfer stickers , Tattoo stickers, Nail stickers	<p>Amusement toys :</p> <ol style="list-style-type: none"> Stickers toys with cartoon/animal shape for children playing. Sticker books with interactions for children learning or scenes playing. Transfer stickers, tattoo stickers, and nail stickers for children role-playing. 	<ol style="list-style-type: none"> Characterization of commodity: Major composition of the stickers is paper or plastic and for one-time using or sticking . Children use the commodity to induce low major or immediately hazard risk. Testing results and market surveillance: Sporadic case of unsatisfactory situation. Information of unsafe

Educational/observing toys such as telescope/camera, planting sets	<p>Kindergarten toys :</p> <p>Label and advertisement for children. Only for Educational/observing toys such as telescope/camera, planting sets.</p>	<ol style="list-style-type: none"> 1. Characterization of commodity: Major composition of the commodity is plastic. Children use the commodity to induce low major or immediately hazard risk 2. Testing results and market surveillance: None of unsatisfactory situation. 3. Toy stamp(set),toy pen	<p>Stationary toys :</p> <ol style="list-style-type: none"> 1. Pen attached with toy commodity. 2. Toy stamp or toy stamp set (inkpad) with cartoon/animal shape. 	<ol style="list-style-type: none"> 1. Characterization of commodity: Major composition of the commodity is plastic. The major purpose is for stationary use. Children use the commodity to induce low major or immediately hazard risk 2. Testing results and market surveillance: Sporadic case of unsatisfactory of phthalate. 3. Information of unsafe commodity safety from domestic and foreign: None of major damage case. 4. Damage caused from unsafety commodity: Major risk of hazard is chemical hazard such as heavy metal or phthalate. 5. Identification of risks of hazard: Low.

Damage caused from unsafe commodity: Major risk of hazard is chemical hazard such as heavy metal or phthalate. 5. Identification of risks of hazard: Medium.
