

Annex I

Inspection Fee Rates and the Minimum Inspection Fees for Batch-by-Batch Inspection and Monitoring Inspection

For commodities to be exported, imported or domestically manufactured and distributed under batch-by-batch inspection or monitoring inspection, the following rates and minimum fees for each batch of commodities shall apply.

1. Batch-by-Batch Inspection and Monitoring Inspection:

(1) Chemical fertilizers and gasoline products

- I. Fee rate: 0.1%
- II. Minimum fee: NT\$500.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.05%.

(2) Rubber tires, indoor fire-resistant modelling or decoration materials:

- I. Fee rate: 0.3%
- II. Minimum fee: NT\$1,000.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.15%.

(3) Wheat, barley, maize (corn), and soybeans:

- I. Fee rate: 0.05%
- II. Minimum fee: NT\$200.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.075%.

(3-1) Agricultural, fishery products, and processed products thereof, except wheat, barley, maize (corn), and soybeans:

- I. Fee rate: 0.15%
- II. Minimum fee: NT\$200.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.075%.

(4) Products only requiring EMC inspection:

- I. Fee rate: 0.1%
- II. Minimum fee: NT\$300.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.05%.

(5) Air conditioning machines:

- I. Fee rate: 0.27%
- II. Minimum fee: NT\$1,000.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.135%.

(6) Information technology equipment:

- I. Fee rate: 0.1%.
- II. Minimum fee: NT\$350.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.135%.

(7) Textile products (garments, underwear, sweaters, swimwear, towels, hosiery, bedding, headgear, scarves, gloves, curtain, protective apparatus), ceramic tiles, bags, cases, trunks and footwear commodities:

- I. Fee rate: 0.1%.
- II. Minimum fee: NT\$200.
- III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.05%.
- IV. When applying for random inspection on yearly basis, the fee rate is 0.1%, and the minimum fee is NT\$ 3,000. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.05%.

(8) Other commodities:

- I. Fee rate: 0.25%.
- II. Minimum fee: NT\$500.

III. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.125%.

IV. When applying for random inspection on yearly basis, the fee rate is 0.25% , and the minimum fee is NT\$ 3,000. If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.125%.

2. Monitoring Inspection with Certified Management Systems:

(1) For commodities that are entitled to management-system-based monitoring inspection subject to certified management systems

(2) Fee rate: 0.02%.

(3) Minimum fee: NT\$100.

(4) If the inspection fee is more than NT\$100,000, the portion above NT\$100,000 shall be collected at the rate of 0.01%.
