1. Identification document: (1) For natural persons, attach a copy of both sides of their National ID card. (2) For companies (juridical persons) or companies in preparation, attach a copy of the latest company registration (modification) form, or the name reservation and business scope pre-examination approval document, and a copy of the responsible person's ID card. (3) For sole proprietorships or partnerships, attach a copy of the business registration approval document and a copy of both sides of the responsible person's identification document. (4) For unincorporated organizations established in accordance with the law and having a representative or manager, attach relevant registration, establishment, or filing documents and a copy of both sides of the representative's or manager's identification document. (5) For government agencies (or entities), the official seal of the agency (or entity) shall be affixed, and an official letter indicating the responsible person shall be provided.
2. Land use consent documentation for the Exploration Site: (1) For public land, attach a letter of consent or approval issued by the land administration authority. (2) For privately leased land, lawful notarization is required. Contract terms must include provisions for sealing, plugging, dismantling, or handling structures installed pursuant to the permit, and other appropriate measures designated by the competent authority. (3) Where the applicant is the landowner, a copy of the land ownership certificate may be submitted in place of a consent letter.
